Justin Irvine

Dr. Justin Irvine's research addresses issues associated with conflicts over conservation and land-use and in particular. His main focus is on the

interaction between Land-use and biodiversity with the aim of using this information to inform policy and practice. His interdisciplinary research led to an EU funded project looking at biodiversity conservation and the relationship with hunting as a land use (fp7hunt.net). These topics led to him coordinating Scottish Government funded research on implementing the Ecosystem Approach at a range of scales where he is developing processes that explore how land use decisions influence ecosystem service delivery and how this approach can be used to plan for resilience to future change.

He is a Member of the Scottish Natural Heritage's Deer Management Round Table and the Cairngorms Deer Advisory Group and adviser to the Association of Deer Management Groups.



Konstantin Kostopoulos

Mr. Kostopoulos worked as a member of the team of Greek officials tasked with the negotiations for the accession of

Greece to the European Community, particularly on agricultural issues. For a period of three years

(1985-1989) he took up duties as an agricultural expert in the FAO of the United Nations in Rome (Commodities and Trade Division). In 1994 he joined the European Commission (Directorate General for External Relations) and worked in the areas of technical and financial assistance to Eastern Europe and later in the negotiations on enlargement. For the period 2004-2010, Mr. Kostopoulos was detached to the cabinet of the Greek Commissioner for the Environment, where he was responsible for economic and budgetary affairs, agriculture and regional development, the soil strategy, the LIFE+ programme and CO2 emissions.



David Scallan

Dr. David Scallan is the Wildlife Policy Officer at the European Federation of Associations for Hunting and Conservation (FACE). He deals with a variety of dossiers including migratory

birds, land use and the economics of hunting. David has a strong background in conservation policy, game management, sustainable agriculture and human-wildlife conflict. He received his Ph.D. from the National University of Ireland Galway in 2012, with a dissertation examining the economic, ecological and social place of hunting in rural Ireland.
