Benefits of hunting in Europe

Hunters' Key Demands

Members of the European Federation for Hunting and Conservation (FACE) are inviting all candidates running in the 2024 European Parliament elections to sign this campaign manifesto, calling for:

- 1. Laws and decisions** which affect hunting and conservation to be fair, workable, and understandable whilst respecting the **principles of subsidiarity** and proportionality.
- 2.** A flexible implementation of the **EU Nature Directives** in accordance with the principle of sustainable use and a balanced consideration of the interests of rural areas.

- 3.** Europe's **cultural heritage** to be respected, which is vital to the future of a diverse Europe, thereby enriching the lives of citizens.
- 4.** Recognition of the important role of the **hunting community** in conserving nature.
- 5.** The re-establishment of the **"Biodiversity, Hunting, Countryside" Intergroup** for the 2024-2029 parliamentary term.
